TERRITORY	<ul style="list-style-type: none"> - Worldwide - Attention: we have access to 500 shops. This doesn't imply that your music productions will be sold in all shops. This is due to: <ul style="list-style-type: none"> - Some shops only sell a specific genre; - Other shops evaluate the tracks and make a selection. - Exceptions are possible on request.
CONDITIONS	Both parties are justified to immediately terminate the collaboration.
TERMINATION	Termination must be done in certified writing or certified e-mail.
PERIOD OF RIGHTS	An offered release remains at minimum one year and three months online.
MECHANICAL RIGHTS	<p>You give permission to Free Music Publishing for the worldwide collection and exploitation of your mechanical rights against a by law fixed percentage (33% up to 50%. This differs per country).</p> <p>DistributionLabel.com has to register your track(s) at the publisher Free Music Publishing (FMP). Track(s) will stay full property of the author and can be removed from the publishing at all times. After removal of a title from the publisher FMP, collection of mechanical rights and exploitation of that title will not be continued by FMP. CHANGES	You have the right to submit changes in the offered releases (catalogue). Changes in already offered releases costs € 30 per change. In case of complete removal of a release costs are € 40.
CONTROL	You have the right to check the account statements by an (in The Netherlands) acknowledged accountant on your own costs. This has to be announced 30 days in advance.
